- **Safety Topic** March is Brain Injury Awareness month. Some pertinent facts and statistics:
 - Acquired Brain Injuries (ABIs) are injuries to the brain that are not hereditary, congenital, degenerative, or birth trauma induced.
 - Traumatic Brain Injuries (TBIs) are a more severe subcategory of ABIs and are a major cause of death and disability in the U.S.
 - In the US, an ABI occurs about every 9 seconds and can include electric shock, infectious disease, lightning strikes, hypoxia (or oxygen deprivation), toxic exposure, vehicle accidents, stroke.
 - There are about 3.6 million ABIs and 2.8 million TBIs sustained each year.
 - At least 5.3 million Americans live with a TBI-related disability, which is about 1 in every 60 people.
 - TBIs contribute to approximately 30% of all injury related deaths.
 - The leading causes of TBIs include falls (48%), being struck by something or against something (17%), and motor vehicle accidents (13%).
 - Focusing on the facility and construction environment, a useful acronym to remember is SAFE
 - <u>S</u>urface Consider what surface you're working on, its condition, any changes in elevation, etc...
 - Attention Being aware of your surroundings when working at heights.

- <u>F</u>ootwear Making sure you've got the appropriate PPE, not just an appropriately related helmet or steel-toed shoes, but also good traction on the soles.
- <u>E</u>nvironment Includes weather awareness, making sure there's adequate lighting, dryness, or any other environmental factor which could contribute to a fall.

- 1.2.2 & 1.2.3 Maturing EFCOG bias management training materials and pilot training (Josh Ramirez)
 - Latest update: Exploring opportunity to conduct training at SRS and PNNL
 - Action Item -
 - SRS has completed transition. Diane to reach out to new training manager.

- **Ad Hoc Discussion Topic** How to incorporate Category 1 risks and estimate uncertainty into cost and schedule estimates within an IDIQ FAR-based contract structure without them being targeted for removal as part of final contract negotiations.
 - Somewhat tricky issue, which is why it is important for the group to provide appropriate feedback to the Acquisition Support Group best practices initiative.
 - Need to maintain alignment with GAO 12 steps best practices for cost estimating, while also meeting policymaker mandate for not calling out MR as a separate entity (traceability vs. transparency).
 - Multi-faceted challenge:
 - Ensuring adequate risk reserves for (potentially under-defined) task order scope
 - Providing clear BOE documentation to justify cost and risk build-up
 - Clearly documenting assumptions on inclusions/exclusions and ensuring correct risk ownership assignments (contractor vs. DOE) as part of cost negotiations to mitigate downstream REA claim conflicts
 - Adjusting to different COs with respect to individual preferences and risk tolerances
 - Navigating potentially conflicting cost grouping requirements between current DOE IDIQ policy and EVMS Gold Card.
