Guest Presentation: Intro to FAR 52.246-26 and DOE applicability Presenters:

- Gabrielle Holcomb (DOE-HQ, Chair DOE SCI Working Group)
- Tammie Graham-McGuire (Lawrence Livermore National Lab)

Presentation focused on understanding two major concepts. The reporting of Suspect/Counterfeit Items (SCI) and major/critical nonconformance reports to the Government Industry Data Exchange Program (GIDEP). In her paper, Tammie addressed how Sandia National Lab and Lawrence Livermore National Lab implemented the FAR clause after it was added to their contract. Guest Presentation: SRS Electronic records Presenter:

• Cheryl Ludwick, SRS Manager for Enterprise Control and Support Services Presentation focused on how SRS manages and maintains electronic records in accordance with DOE O 243-1B which invokes 36CFR1236.10 and 36CFR1236.12.
