ORNL Presentation - ORNL Software Registration System Overview by Terry Scoggins

1. David Louie of SNL, had the following questions:
 - a. Do you look at external software? Terry responded: yes, software developed or purchased.
 - b. Isn't there a lot of email going out from system? No, one email covers all things triggered. Software Owner gets 1 email a year.
 - c. If a company goes bankrupt, how is that notified to SME? If a company our lab bought software from, the Software Registration System (SRS) would be a trailing issue. The functional owners would know right away.
 - d. What about software that is still in use, after it is no longer supported? There is a phase in SQAPP for retiring software.
 - e. Would the links at the SRS to software retired be removed so they are not accidentally invoked? No, the SRS entry is marked as retired. SRS does not prohibit use, the steps/tasks in retirement are followed.
 - f. What about multiple instances of software, are they tracked in the SRS, so that if the software is retired, all instances are retired also? Just because a software application is retired, doesn't mean all instances are retired/removed. This could be a difficult task to do.
2. Teri Vincent is interested in the steps used for retirement.
3. Carol Olijar asked:
 - a. If the SRS could be available to other labs? Terry responded labs may have more modern systems, the SRS is over 10 years old, and it may be available for other labs to use. Teri Vincent noted her lab uses SAP.
 - b. In the SQA matrix slide, is it based upon DOE G 414.1-4 SQA Guide, Table 4 Mapping Safety Software Types and Grading Levels to Software Quality Assurance (SQA) Work Activities? Terry responded he thought so.
4. Donna Riggs of Riggs Consulting, asked in chat: "As Software Tools was not highlighted in yellow, how are they acquired and controlled outside the SQA program". Donna noted, she feels they need to be under configuration management control, such as third-party applications acquired for software applications development. Terry responded Software Tools should have been highlighted in yellow, as a field that is entered information for SQA.
5. Patrick Faulk of BNI, asked in chat: "Is this fully in-house developed, or based on a commercial product? Question answered in comments above.
6. Christian Palay of AU-32 asked in chat: "why would they be acquired and controlled outside the SQA program?". Question answered in comments above.

Sub-Tasks Group Updates:

1. For Toolbox Alternatives, Pat mentioned he is working with Chris of AU-32 on survey questions.
2. For Software Standards and Orders, Christy Renner of PORTS, mentioned in email that there is one more piece to be finalized, and she needs help drafting the white paper.

Next Steps:

1. Marlene Underwood of PORTS in chat asked: "Can we get a status on the DOE SQA guide?". The meeting had ended when her chat came up. I believe there will be a status provided by Chris of DOE AU-32 at the fall meeting.
