1.0 PURPOSE

The purpose of this Memorandum of Understanding (MOU) is to document agreement and concurrence from NNSA Contractor Sites to NNSA/Weapon Quality Division (NA121.3) based on the outcome of activities defined from the October 17, 2018 NSE Supplier Quality Working Group Workshop. The outcome from the workshop commissioned two working teams to integrate supplier assessments conducted across the NSE, create a unified process so supplier assessment reports can be shared across the NSE, identify improvements necessary to allow the eight (8) NSE NNSA Contractor Sites to conduct, share, and accept each other's supplier assessment results in accordance with NAP-24A Weapon Quality Policy 11-24-15 as well as future NAP 401.1 Weapon Quality Policy Attachment 6: Requirements for Suppliers. In addition, the workshop objectives also addressed findings borne out of the July 2018 DOE IG 18-41 assessment on supplier quality.

This MOU is effective upon July 31, 2019. Signatories, including concurrence attachments, signify NNSA Contractor commitment of the activities, listed in *Attachment A-NSE Supplier Quality Working Group Workshop Action Items List* (dated 7/31/2019), as well as continued support activities necessary for continuous improvement. This MOU shall be reviewed by the signatories and updated as necessary.

2.0 OBJECTIVE

The objective of this MOU is to define the activities, negotiated in FY19, between NSE Sites to enable sharing of supplier quality management system information and future continuous improvement activities for sustainment.

3.0 ORGANIZATIONAL RESPONSIBILITIES

3.1. The primary NSE Supplier Quality Working Group Steering Committee responsibilities include the following:

Provide strategic direction and support so that we can be successful in accomplishing our goals. Specifically, supporting the working groups (Procurement and Supplier Quality) in the following ways:

- Ensuring people, funding, other needs are available
- Acceptance of working group deliverables (as they are completed)
- Providing the leadership influence necessary to overcome the many obstacles that are inherent in large institutions such as the NSE
- Helping to balance conflicting priorities and resources
- Providing communication regarding the project's progress and outcomes
- Providing advice and making decisions about changes to the project as it develops

3.2 The primary NSE Supplier Quality Working Group responsibilities include the following:

- Define project charter, objectives, and cross-site working teams
- Establish work plans and action items
- Incorporate changes to NNSA Contractor Site policy, procedures, and processes

4.0 LEGAL DISCLAIMERS

- Individual Prime Contractors using a report prepared by another Prime contractor are responsible for determining suitability of audit reports contained in MASL as they pertain to their contract.
- Audit reports loaded into MASL can include reports identified as Official Use Only (OUO).
- Supplier evaluations should not cover information that would normally be considered confidential, proprietary, or a trade secret.
- Each Contractor must comply with nondisclosure agreements with suppliers. The standard nondisclosure agreement states that proprietary information is "...any information, technical data or know-how in whatever form that is not generally known and is clearly identified as being confidential, proprietary or a trade secret."
- Supplier evaluations are intended to ensure that the supplier has a quality management system in place and that it will be able to meet the requirements of NQA-1 / NAP-24A, NAP 401.1 as applicable.
