- Cost avoidances will show DOE and management that this is an effective system to use, so please enter them
- Auditing of data is constant as there were data issues brought over from the old system. The current project is duplicate mapping to consolidate suppliers that are in multiple times (i.e. ABC Company, ABC Company Inc)

  - Watch for counterfeit KN95 masks reported by Brookhaven. This is on Gabby's S/CI list
  - o Poor quality aluminum from China
  - Suspect counterfeit parts
  - \*Remember to share information and avoid supplier relationship strains associated with multiple/duplicated audits.
  - \*Remember NOT to tell suppliers they will not be audited for 3 years if in MSL (other sites could require different standards, or the audit material may not be acceptable for some sites)
  - \*Remember to include SMEs (DOT packaging, welding) on supplier audits (not a requirement)
