  - \*Remember to include SMEs (DOT packaging, welding) on supplier audits (not a requirement, but a good practice)

Common Errors included on slide – Please be mindful of what you are entering. Assure it is complete and usable to another user. Jim White – Why would someone put an open report with corrective actions in MSL?

The information in MSL is to indicate to the rest of the 'world' that you have gone to or plan on going to that site. It is ok to put the report in MSL when complete as it will clearly state that there were corrective actions during the assessment as well as let another site read on what was found at the visit. A 3<sup>rd</sup> party review cannot be done on the report at this stage, but it can still provide information to other sites. When the SCARs are finally closed, ideally you should circle back around and upload that information. That will 1) make the information immediately usable for a 3d party review for other sites and 2) eliminate the site

wanting to use the information from having to locate a person to get the closure information causing delays in the completic of their review. This will be included as a discussion point in the MSL session of the Fall Conference.
