## **SME'S ON SUPPLIER AUDITS – Helps with Cost Avoidances & Good Business Practice**

DOT Packaging suppliers - If you are doing an audit of a DOT packaging supplier. You need to have a DOT SME along for the audit, or at least an a DOT checklist provided to a QA auditor who has been trained in DOT. It's a good idea to interview the SME to make sure of his qualifications.

Welding programs – If you are doing an audit of a supplier who is doing welding or providing welding materials you need to have a CWI or similar type welding SME.

There may be cases where you need to bring both a DOT and Welding SME. If no specialized welding is required you may not need a Welding SME.

Abstract: **MTI** received documentation with only a packing slip for part number M55342K11B24D9RTSV.

NetSource was contacted and a request was made for either: test data on current stock, proof of traceability, or written approval from **Vishay**.

NetSource claimed that they had an NDA with their supplier (OEM Excess) and could not provide MTI with any additional information. MTI offered to sign a 3-way NDA with both suppliers and host a call with all of the involved parties to get the information needed.

NetSource then stopped responding to neither emails nor phone calls. September 11, 2023

**9/13/2023 Bill contacted Gabby to find out the name of MTI and the location of Vishay.**

**Via Gabby: Based on the report (KDJ-A-23-01) I have gathered the following information: The manufacturer is: Vishay Thin Film LLC 2160 Liberty Dr. Niagara Falls, NY 14304-3727. The supplier is: NetSource Technology, Inc. 951 Calle Negocio San Clemente, CA 92673 The report originator is MTI Motion. MTI Motion is a wholly owned operating company within the Steel Partners (NYSE: SPLP) family of companies and is headquartered in Pleasant Prairie, WI, with facilities worldwide.**

Pursuant to DFARS 252.246.7007, Aerospace Elite Electronics is submitting this notice regarding obsolete part number MGA-85563-TR1G, an RF Amp Single LNA 6GHz Spin SOT-363 with lot date code 1634 and 1638. Parts were received by the customer, and part failures resulted in X-ray analysis by the customer which revealed internal die anomalies and missing wire bond terminations. Insufficient x-rays provided at time of test review to Aerospace Elite and to the end customer led to the escape which led to the line failure. AEE placed PO# 10127010 (LDC 1638) and 10126984 (LDC 1634) with Zeebaware, Zeebaware did not have stock of this PN and procured the material from a 3rd source located in Taiwan. Parts were purchased by Zeebaware from Udison Trading Co Ltd under PO# Z W1072 and PO# ZW1064.

The following pages show that the components were not new and that the solderable leads were re-plated with a material that is not offered from Texas instruments.

The component in question is part number is STM32L496VGY6 (CPU, ARM CORTEX M4L, 80MHz, 1024KB FLASH, 320KB RAM, -40-85C, WLCSP100). We had two batches of components, one from a known good supplier and the other from a new supplier (E- Rize CO.). The entire batch of parts from the new supplier (E- Rize CO.) would not function after being installed on the PCB. Additionally, all parts from the new supplier (E-Rize CO.) had the top coating on the parts flaking off the body of the component after the solder baking process. July 3, 2023

Lot code is not possible as the assembly plant indicated in the lot marking stopped assembly these items 5 years prior to the date code marked on the part. - GETS test report attached in GIDEP - Mfr reply: Milpitas stopped loading SOT227 products to TPC in 2017. So, these units could not be assembled in TPC. These units are FAKE. June 19, 2023

- We will be checking the MSL for ‘violations’ and contacting people individually!
- Kinds of errors found:
  - No auditor name (There should be an Owner name and at least the Lead Auditor name)
  - No start date (if you did an assessment, there is a start date or a scheduled start date **and it is indicated on your report. Please use this date**)
  - Incorrect site identified (the site should always be the site who did the assessment even if you do it for another site)
  - No assessment method (if you did an assessment, there was a way you did it)
  - Not checking to see if supplier already exists and adding same one in a different naming format
  - Prefer and strongly recommend (but not required) a comment indicating pending SCARs
  - Prefer and strongly recommend (but not required) updating record once SCARs are closed and uploading. **It eliminates having to contact the site POC for it which can result in delays.**
  - **\*New\*** Using the future expiration for ‘Event Start Date’ when entering a cost avoidance. This should be the date (or approximate) when the original site report was used. The ‘Event Complete Date’ should be the date (or approximate) when the review of the report was complete.
- **Kristin will be releasing new user guides to cover some of these things October 2023.**
- **There will be emails going out to the people who entered these, to try to fix future entries.**
- **Our goal is to have the best quality of information in MSL!**

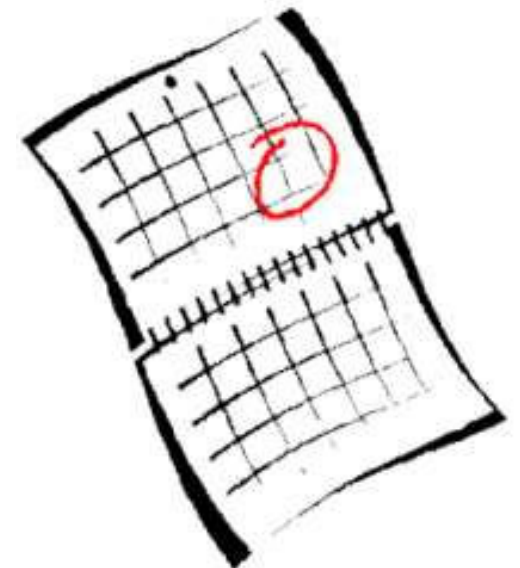

### Who is Eligible to Grant ISO 9001 Certification?

- So who is eligible to grant ISO 9001 certification? Many people assume that ISO grants certification, but in fact, this is not true, instead, a registrar or certification body (CB) will be the one to grant certification (Read: [Who is ISO?](#)). When choosing a registrar a supplier should make sure that they are accredited. They should be a member of the International Accreditation Forum (IAF), and additionally need to be ISO/IEC 17021:2015 certified.
- One of these standards is [ISO/IEC 17021:2015 Conformity assessment](#) “**Requirements for bodies providing audit and certification of management systems**“, which in effect stipulates the requirements for Registrars who certify organizations to ISO management standards like ISO 9001, ISO 14001, etc.
- People often say “[ISO Certified](#)” but ISO does not issue certificates or certify individual companies to any standard. So who can Grant ISO 9001 Certification? They are issued by certification/registration bodies (also called Registrars or CB’s), which are independent of ISO. CB’s need to be accredited by an IAF member to be internationally recognized.
- [ISO/IEC 17021](#) ensures international acceptance of the CB’s certifications (i.e. your ISO 9001:2008 certificate) by requiring that all Accreditation bodies ([ANAB](#), etc.) belong to an internationally accredited organization, like the [IAF](#). Likewise, the IAF ensures that CB’s comply with ISO/IEC 17021.
- Some Quality System Registrars are not accredited by IAF, and thus are not meeting [ISO 17021](#) — and **will not be internationally recognized**. Make sure that you [choose a Registrar](#) who is accredited by an [IAF member](#) (ANAB or the equivalent of ANAB in your country or region).
- 11/2022, Amber Romero checked and we are not allowed to issue AS-9100 certs to our suppliers even if we were accredited, as this would be considered a conflict of interest.
