

*NOTE: Local help desks can help with credential options, but they do not support MSL.

Step 3 – MSL Self-Enrollment

- Select MSL as the site you want access to.
- You will be prompted through next steps for contractor type, site and edit or view access.

SME'S ON SUPPLIER AUDITS – Helps with Cost Avoidances & Good Business Practice

DOT Packaging suppliers - If you are doing an audit of a DOT packaging supplier. You need to have a DOT SME along for the audit, or at least an a DOT checklist provided to a QA auditor who has been trained in DOT. It's a good idea to interview the SME to make sure of his qualifications.

Welding programs – If you are doing an audit of a supplier who is doing welding or providing welding materials you need to have a CWI or similar type welding SME.

There may be cases where you need to bring both a DOT and Welding SME. If no specialized welding is required you may not need a Welding SME.

Title: <u>SUSPECT COUNTERFEIT, DIGIKEY LABEL AND PAPERWORK</u> Abstract: On 22-March-2023, <u>DigiKey Electronics-Shanghai was</u> contacted by a person (person's name unknown) claiming to be Beijing Guangyuan Jiarui Technology Co., Ltd. through webchat, <u>asking what</u> information is on a DigiKey label and for an example of a DigiKey delivery note. The person claiming to be Beijing Guangyuan Jiarui Technology Co., Ltd. provided a photo of what appeared to be a DigiKey pre-pack label and what appeared to be a DigiKey invoice/pack-slip. The DigiKey representative attempted to gather more information to verify the origin of the label and paperwork. The DigiKey representative wanted more information to verify the caller with the phone number provided. The DigiKey representative became suspicious and contacted DigiKey headquarters, USA. DigiKey headquarters, USA, investigated the information on the label provided, and identified several incorrect or missing fields which confirmed the label to be counterfeit. For example, traceability and identifying information are partially unreadable; part ID is crossed off, but the first two digits are '10'. The part ID for this product does not begin with '10'. Additionally, DigiKey had never received the date and/or lot code that was depicted on the label. No order shipped from DigiKey for the product ID depicted on the label and packlist. DigiKey concludes the label and paperwork are not authentic to DigiKey, and confirms they were misrepresented to appear as if they came from DigiKey. October 23, 2023





- Adding the supplier again for a new assessment instead of adding it under the location already there
- Keep in mind that exports reflect your entry. Avoid copying and pasting in multiple formats.
- Incorrect formats for emails
- No start date (if you did an assessment, there is a start date or a scheduled start date and it is indicated on your report. Please use this date). There are functions within MSL that rely on this data.

Reminders:

Update your record once SCARs are closed. Other sites should be able to get everything within MSL without having to track down the correct person with documents.

- Expand supplier list to include suppliers who are not required to undergo on-site assessments by NSE. Make SCRM reviews and desk assessments available to users for these suppliers. This would add over a thousand additional suppliers to the MSL, covering a wide variety of commodities and capabilities.
- 5/17/23 Looking to hire a full-time person who would potentially provide risk assessments to other NSE sites as a pilot. This would ideally be provided within MSL for retrieval. Desk assessments (similar to PQR 1010s) would also be available. Thousands currently on hand that could be loaded initially for the NSE sites. Background checks would be only on vendors that exist already in MSL. Profiles would need to be added for the desk assessments.
- 6/21/2023 Support Team meeting scheduled to discuss
- 10/18/2023 Amber will provide at the Spring 2024 EFCOG SCQ CoP Meeting, training on how to do a similar risk assessment for themselves if they have Exiger access. There were a few people who expressed they would be interested in this. Need to add to the Spring 2024 meeting agenda.
- Jan 2024 SCMC employee Joshua French will be a POC for SRAs performed by SCMC. Training is underway.
- Feb 2024 Amber is in the process of putting the completed Cybersecurity questionnaires into the MSL.

Goal: To share best inspection practices

Discussion:

- Share "best in class" quality inspection techniques for hardware and electronics
- 5/17/23 Steve CdeBaca and Gabby Holcomb put together a video to inspect a phone charger. Amber looking for effective and quick ways to train people who open packages such as laptops, phones, chargers, etc.. and teach them how to inspect those items. Ideally, she would like to make videos to share with the complex. Stefan Komarek (*skomarek@kcnsc.doe.gov*) working with teams to house videos, possibly this could be a team effort.
- Two great inspection videos produced by Gabby Holcomb are:



Who is Eligible to Grant ISO 9001 Certification?

- So who is eligible to grant ISO 9001 certification? Many people assume that ISO grants certification, but in fact, this is not true, instead, a registrar or certification body (CB) will be the one to grant certification (Read: <u>Who is ISO?</u>). When choosing a registrar a supplier should make sure that they are accredited. They should be a member of the International Accreditation Forum (IAF), and additionally need to be ISO/IEC 17021:2015 certified.
- One of these standards is <u>ISO/IEC 17021:2015 Conformity assessment</u>
 "Requirements for bodies providing audit and certification of management systems", which in effect stipulates the requirements for Registrars who certify organizations to ISO management standards like ISO 9001, ISO 14001, etc.
- People often say "<u>ISO Certified</u>" but ISO does not issue certificates or certify individual companies to any standard. So who can Grant ISO 9001 Certification? They are issued by certification/registration bodies (also called Registrars or CB's), which are independent of ISO. CB's need to be accredited by an IAF member to be internationally recognized.
- <u>ISO/IEC 17021</u> ensures international acceptance of the CB's certifications (i.e. your ISO 9001:2008 certificate) by requiring that all Accreditation bodies (<u>ANAB</u>, etc.) belong to an internationally accredited organization, like the <u>IAF</u>. Likewise, the IAF ensures that CB's comply with ISO/IEC 17021.
- Some Quality System Registrars are not accredited by IAF, and thus are not meeting <u>ISO 17021</u> and will not be internationally recognized. Make sure that you <u>choose a Registrar</u> who is accredited by an <u>IAF member</u> (ANAB or the equivalent of ANAB in your country or region).
- 11/2022, Amber Romero checked and we are not allowed to issue AS-9100 certs to our suppliers even if we were accredited, as this would be considered a conflict of interest.




