# Lessons Learned from Enforcement Activities



- Ensure work is performed within the defined scope
- Clarify to workers the hazards and controls associated with their assigned tasks – don't rely exclusively on skill-of-thecraft
- Engage Subject Matter Experts in work planning and control
- Consider NFPA 70E when evaluating electrical safety deficiencies
- Communicate DOE regulatory expectations to subcontractors



### Lessons Learned from Enforcement Activities (Continued)



- Use assessments to identify noncompliances before they result in events and worker injury/illness
- Perform self-critical evaluations of events and noncompliant conditions, including emergency response actions
- Determine the extent of noncompliant condition(s)
- Effectively address causal factors, noncompliances, and extent of condition(s) to prevent recurrence



- Procedures incorporated into WSHP (851.10(a)(2)(ii))
- Hierarchy of controls (851.22(b))
- Fall protection (1910 and 1926)
- Thermal stress (ACGIH)
- Ergonomic hazards (ACGIH)
- Exposure assessments and industrial hygiene program (851 Appendix A.6)
- Occupational medicine programs (851 Appendix A.8)

#### Request for Investigation Part 851.40(c)



Any worker or worker representative may request that the Director initiate an investigation or inspection...relating to the scope, nature and extent of compliance with 851.

Requests in 2013:

- Violation of Missouri DOT signage rule
- Workers accessing tunnels
- Adverse weather communications
- Discrimination claim
- Fitness for duty process
- Employee exposure record concern
- Industrial hygiene instrument use
- Worker retaliation
